

## MOTION FOR LIMITED DRIVING PRIVILEGES

The Juvenile Traffic Court may grant a child whose driving privileges have been suspended by the Cuyahoga County Court of Common Pleas, Juvenile Division, limited driving privileges.

A person may request the limited driving privileges by filing a Motion to Modify Driving Privileges in the juvenile court's clerk's office located on the second floor of the Juvenile Justice Center. The filing fee is \$20.00.

The person filing the motion must bring or send the motion to the Cuyahoga County Court of Common Pleas, Juvenile Division, 9300 Quincy Avenue, Cleveland, Ohio 44106 along with the filing fee of \$20.00.

**\*\*You must first pay all of your court costs, fines, filing fee of \$20.00 and any other court order completed before filing this motion.**

The court shall rule upon the motion **within** a two week period of the filing date of the motion.

If the court grants the request for limited driving privileges, you will receive a copy of the court's order granting the limited privileges and you must carry these orders with you at all times while driving.
