

MOTION FOR LIMITED DRIVING PRIVILEGES

The Juvenile Court may grant an individual whose driver's license has been suspended by Cuyahoga Job and Family Services-Office of Child Support Services (CJFS-OCSS), limited driving privileges when an action for contempt due to non-payment of child support against the person has been filed in juvenile court.

A person may request the limited driving privileges by filing a Motion for Limited Driving Privileges in the Juvenile Court's Clerk's Office located on the second floor of the Juvenile Justice Center. The filing fee will be \$25.00.

The person filing the motion must send a copy of the motion to Cuyahoga Job and Family Services-Office of Child Support Services, P. O. Box 93318, Cleveland, Ohio 44101.

You must obtain a copy of a driver's abstract from the registrar of motor vehicles and provide a copy to the court. See <http://bmv.ohio.gov/abstract.stm> on how to obtain your driver's abstract. The abstract should either be attached to the motion or brought to the hearing on the motion.

Once the motion is filed, the court will schedule a hearing. At the hearing, CJFS-OCSS will provide the court with an oral or written position of the agency regarding the issue of granting limited driving privileges. The court is not bound by CJFS-OCSS's position, but it will take it into consideration.

You must also attach to the motion or bring to the court, proof of financial responsibility.

If the court grants limited driving privileges, you will have a copy of the court order that grants the limited driving privileges when you are driving.

If after being granted limited driving privileges and you violate a traffic law, your limited driving privileges will immediately be suspended pending a reinstatement hearing.
