



**CONDITIONS OF PROBATION  
FOR COMMON PLEAS COURT  
Juvenile Court Division**



The Judges of the Court have ordered that your probation shall have certain conditions. They have extended this privilege to you because they believe that supervision will help you stay out of trouble and avoid another appearance in Court. They want the Probation Officer to help you respect other persons, their rights and their property. Any violations of the conditions of probation may subject you to further Court action.

- You are prohibited from possessing any weapons, including: a gun, knife, spring gun/pistol, BB gun, pellet gun or any object that a reasonable person could perceive as a weapon in person and/or on social media.
- Obey the laws of the City in which you live, Cuyahoga County and State of Ohio as well as the United States. If detained, questioned by a Law Enforcement Officer or arrested for any reason, you shall notify your Probation Officer immediately. \_\_\_\_\_ P. O. phone number
- You will not associate with any persons with whom you have been involved in any criminal act or violation or are presently known to be on probation or parole.
- You are not to leave the County/State without receiving permission from your Probation Officer. If permitted to travel, stay in the agreed upon destination. Notification is required before you travel and upon your return.
- Provide proof of address, phone number and employment when required to do so. Notify your Probation Officer within 48 hours of any changes in your address, phone number or work status.
- If you are attending school, you will attend school regularly and obey all school regulations. If you are suspended or expelled, you are required to notify your Probation Officer immediately. You may be required to attend a Court program. Notify your Probation Officer if you withdraw from school or are enrolled in a new school.
- You are not to use drugs, alcohol or any medication not prescribed for you. You are not to sell drugs or be in possession of drugs or paraphernalia. Compliance will be monitored through random urine screens at your Probation Officer's discretion.
- You may be monitored by an electronic device to ensure your compliance with Conditions of Probation.
- Keep appointments with your Probation Officer and be on time. If you are unable to meet as scheduled, notify your Probation Officer in advance and reschedule as soon as possible.
- Submit to DNA testing as required under Ohio Law.
- You will attend a mandatory Probation Orientation located at 9300 Quincy Ave. Cleveland, OH. 44106 to learn what is needed to successfully complete Probation.

**PARENTS/GUARDIANS:**

You have a responsibility to help your child follow the conditions of probation and Court orders imposed by the Court and the Probation Officer to the best of your ability. You have an obligation to bring your child to Court as directed and attend service provider and Probation appointments as required. Your participation is expected in all aspects of the treatment as requested by the service provider.
